CONDITIONS OF ACCEPTANCE

1. All animals must be fully vaccinated and current veterinary certificate must be produced at the time of boarding. This certificate is to be left with animal while boarding.

2. A veterinary surgeon shall be called if deemed necessary and the owners will be responsible for any costs arising. Our insurance will cover the costs of any new condition arising during the stay up to £500-00 but costs relating to any known condition will NOT be covered and the owners will be expected to settle their account in full.
Any cat found to have worms or fleas will be given effective treatment and the owners will bear the cost.

3. Whilst all reasonable care and attention is given to every animal boarded, the Cattery and or its staff cannot be held responsible for loss or damage arising through illness or any other cause and the animal is boarded entirely at the owner's risk.

4. Boarding fees are payable at termination of agreed boarding period and the Cattery shall have a general lien on any boarders in respect of unpaid bills.

5. In the event of failure to collect boarder and pay boarding fees within 30 days termination of boarding period the animals shall become the property of the Cattery who shall be free to dispose of such animal in whatsoever manner it shall choose. Nothing herein shall prevent the Cattery from recovering from the owner's unpaid boarding fees to termination of boarding period plus any extension thereof.

6. By signing this contract and leaving this pet with cattery, owner certifies to the accuracy of all information given about said pet on this contract.

7. In the case of sharing this can only be undertaken where animals are from the same ownership/family.

8 . Cancellation Fees will be at the proprietor's discretion. If less than two weeks notice is not received in writing and verbally agreed you may be responsible for part or the full amount.

9. In the case of multiple cats I hereby confirm that I consent to their sharing boarding accommodation.
